The following expenses do not apply to the individual or family Deductible: Services not covered by the plan; fees that exceed Usual, Customary and Reasonable (UCR) charges as established by the plan; copays and Coinsurance for services that do not apply to the Deductible.</li> <li>In-Network - Refers to services received from an extensive network of highly qualified dentists and providers contracted by the Plan.
